Distinguished Member Award

Shirley A. Eichenwald, MBA, RRA

As manager of clinical informatics and case mix/classification systems for Oxford Health Plans, Norwalk, CT, her job description goes beyond the traditional role of the HIM professional.

She has been a catalyst in bringing about changes to how data and services are evaluated in the managed care arena. Through her work with the computer-based patient record and various coding systems, she has designed programs that measure and risk-adjust the performance of providers, created a data integrity function that evaluated the use of inappropriate codes to improve the accuracy and quality of data, and created a clinical audit function to evaluate the quality of services being provided. She has also represented national organizations by writing articles and presenting programs on various classification systems and alternative job opportunities for HIM professionals. Her efforts encourage others to take a fresh look at ways to utilize and develop their skills. She has made many recommendations for systems and users that will change the way healthcare is monitored and reimbursed. Cindy Zak, MS, RRA
