E-HIM Is about Advancing Standards

In this issue, AHIMA professional practice management team members Harry Rhodes, Don Mon, and Michelle Dougherty describe the evolution of a standard for the EHR system in "The Drive for an EHR Standard Picks up Speed." We take standards for granted in our everyday life. When you place a call from your cell phone, for example, standards permit interoperability that make differences in systems and manufacturers transparent.

By contrast, little in health information is interoperable. AHIMA representatives are deeply involved in advancing EHR standards, because without standards there will be no health information infrastructure.

E-HIM also means developing new guidelines. "Your Guide to Implementing the EHR" reports on remarkable work by HIM experts who came together last summer to develop practice guidance on thorny e-HIM issues.

E-HIM Is about Professional Sharing

Transitioning from a paper to electronic paradigm requires pioneers who work through change and share their hard-won knowledge. We thank Michelle Wiczorek for sharing the experience of Saint Vincent Health System in Erie, PA, in "Taking Electronic Document Management beyond the HIM Department." AHIMA will soon publish a case study e-book providing in-depth guidance for the transition to the EHR and related systems.

In "Apples to Apples: Using Auto-benchmarking to Measure Productivity," P.J. Miller and F.L. Waterstraat present a new management technique for monitoring and improving productivity, a key element of e-HIM.
