Earlier this year, during one of multiple trips to Washington, DC, I attended a meeting of the American Health Information Community, the national advisory panel created to accelerate the development and adoption of health IT. One agenda item that really caught my attention was the possibility that future differential reimbursement to providers could be tied directly to the use of certified electronic health records (EHRs).

The Certification Commission for Healthcare Information Technology (CCHIT) sets the gold standard for EHR products and helps advance the adoption of much-needed standards and interoperability. To date, nearly 90 different ambulatory EHR products have been certified, and plans are under way to begin certification of inpatient EHRs. If your organization is not already using a certified EHR, let me encourage you to start asking why not.

Time to Walk the Walk

We have yet to reach a tipping point in EHR use throughout the country, and privacy and security issues still need to be ironed out. However, organizations no longer see technology as a barrier for EHR adoption. Therefore, we can expect greater collaboration and information sharing among healthcare stakeholders and users of health information.

Already we are seeing health information exchange and telemedicine extend well beyond today's institutional care settings. The same information technology that renders walls and borders obsolete for financial transactions is transforming healthcare and reinventing HIM.

AHIMA recognizes that each member of the professional community plays an important part in the healthcare transformation.
