

Ready, Set, Transition to ICD-10-CM/PCS

The year 2015 is upon us and it's time to fill in any last-minute gaps in our ICD-10-CM/PCS training. At this point, most coders have been trained in ICD-10 at the basic or intermediate level, and now it's time to move to a more advanced level of training. Many organizations have structured plans for training their coders during these last nine months leading up to October 1, including dual coding or double coding. However, if you are one of the many coders out there who is doing training on your own, you may need some additional assistance. Here is a sample training timeline that you can follow to prepare yourself for the final stages of implementation.

January

October 1, 2015

- Begin coding all encounters and discharges dated 10/1/2015 and after in ICD-10-CM/PCS

*ICD-10-PCS codes are required for reporting in the hospital inpatient setting. Coders in the outpatient, physician office, and other non-inpatient settings may not need to learn ICD-10-PCS, depending on employer requirements.
